I lodged the WAI 662 claim on Pokopoko (Mangaohane) to the Waitangi Tribunal in 1997 which has brought me down this path to be actively involve in the claims for the hapū and whānau. This claim was lodged for myself and the descendants of Winiata Te Whaaro and the hapu Ngāti Paki.

I am a trustee on Aorangi Awarua, Owhaoko B&D and Te Roopu Ahi Kaa. I believe our hapū deserves answers and justice for the wrong acts of the crown. One major issue for me is "Land Lock Lands" this is a huge issue because most of our lands in Maori ownership do not have reasonable access.

I look forward to future of the claims and settlement of our grievances

This has been a busy time as the reports are large and require a lot of time and further internal research to meet the facts of the reports. Trust Update

Crown Forest Rental Trust (CFRT)

We have come to the end of a successful contract with CFRT and the Trust is currently finalizing a new 12-month contract from 2012—2013. The business for the trust will remain the same and business will be as usual. The claimants mahi will increase as we move into more detailed research reports, updating statement of claims and the introduction of oral and traditional research. We believe the claimants and Trust is in a strong position and look forward to another successful contract.

Legal Representation Update

Aurere Law is in the process of finalizing the updated statement of claim for WAI 1835 Ngāti Hinemanu and Ngāti Paki Blanket Claim. This update was scheduled to be submitted late November 2012. We have held the update back mainly to allow claimants to complete further research. This update will be submitted before the next judicial conference.

Aurere Law has also submitted under direction from the trust to have Ngāti Hinemanu and Ngāti Paki added to the Water Claim WAI 2357 & WAI 2358 which has been granted an urgent hearing.

Water Claim Updates;

This claim will highlight those waterways affected by State Owned Enterprises within the area of interest for Ngati Hinemanu me Ngati Paki. The claim will demonstrate, express and explain how we continue to maintain mana over our waterways highlighting abrogations of that mana (how has that mana been whittled down through Crown acts/policies/ommissions)
