We file this claim in urgency under Section 6 of the Treaty of Waitangi Act 1975.

- 1. We Waina Raumaewa Hoet [retired 88yrs] and Grace Hoet [arts advisor], State Highway 1, Winiata Pa, Taihape, Ngati Kahungunu, Ngati Hinemanu, Ngati Paki are Mãori.
- 2. For our whanau and all descendants of Raumaewa Te Rango, Whatu and Pango Raumaewa of which Waina Raumaewa Hoet is a daughter of the latter and Grace Hoet a great mokopuna.
- 3. We Claim we are prejudicially affected by the actions of past governments whereby the blocks:
 - a) ORUAMATUA-KAIMANAWA 2Q1 1, blocks VIII and XII Moawhango Survey District, and Blocks V and IX, Motupuha Survey District, All Certificate of Title, Volume 112, folio 6, Wellington Land Registry - 1516 acres and;
 - b) ORUAMATUA KAIMANAWA 2Q 2, blocks V and IX, Motupuha Survey District. Balance Certificate of Title, Volume 112, folio 5, wellington Land Registry – 200acres

Whereby these blocks were taken for ROADS a transfer 38917, 29 May 1901, furthermore these blocks were taken for Defence Purposes 23, March 1961. We claim that the taking of these blocks and the issues that arise are contrary to the principles of the Treaty of Waitangi.

- 4. We seek the following relief: The return of the abovementioned blocks as well as the full financial compensation for the loss of and use of our lands this includes the resources contained within the Lands and such other relief as the Tribunal considers appropriate. We also reserve the right to amend any relief that we seek.
- 5. We wish the Tribunal to assign as a WAI number to further a claim to the Tribunal on behalf of our whanau
- 6 We reserve the right to amend this claim, if necessary.
